Emergency Committee Terms of Reference Draft

Membership

The core constitution of the Emergency Committee shall be the Mayor, and the Chair of each of the Council's Committees (Parks, Planning, Policy & Resources and Property).

The Chairman of the Committee shall be chosen from the Members serving on the Committee.

Purpose

This committee will only normally convene, at the request of the Clerk or Assistant Clerk, in the event of a major disruption or emergency which:

- is likely to affect the Council's overall ability to undertake its normal day to day business or the running of its services as set out in the Business Continuity Plan, or
- in the event that there is a major emergency affecting the larger Okehampton area as set out in the Emergency Policy

Terms of Reference

- 1. Following an incident directly affecting the Council, to access the overall impact on the delivery of the council's services in line with the Business Continuity Plan
- 2. Following a major emergency affecting the larger Okehampton area, to assess the overall impact to the community and how the council can assist Emergency Services and residents

Budget

In the that immediate remedial action is required, the Committee may consider suspension of the council's Financial Regulations allowing work to be undertaken without the need to obtain 3 quotations or estimates, up to a value of £2,000. £4,000 (note this is in line with Financial Regulations which were updated in 2022)

Payment of Expenses – To have authority to authorise cheque and BACS payments for all invoices and expenses, during the course of an emergency situation.

Reporting

The Committee shall report to meetings of the full Council as and when necessary.

<u>Emergency Planning</u> – To resolve to create a Task & Finish Group to create an Emergency Plan and to liaise with Launceston Town Council, and others at their invitation, to work collaboratively in this regard.

With the ever-increasing evidence of extreme weather events, some of which appear to be very localised, e.g. the recent flooding in Devon, I believe it would be to the mutual advantage of the towns we represent if we were to discuss the options that might be available to us so that, in the event of another such event, we might be able to seek/obtain (comparatively) local support and assistance. In that way it might be possible for any of the areas to benefit from the resources available in nearby towns.

You will notice that this e-mail is addressed to Town Council's in Devon as well as Cornwall. I realise that may cause a few raised eyebrows but I personally believe that a County boundary should not stand in the way of providing support to a nearby community that requires help.

I believe that if this suggestion has any merit it should be discussed to establish the extent of that support and, if it exists, how we might proceed. To address that question I would suggest that in the first instance we should convene a "virtual meeting" which would hopefully include one or more representatives from each of the Councils to which this e-mail is addressed.

If you and your Council hold similar views I would be grateful if you would indicate your acceptance of my suggestion to convene a virtual meeting. Should there be some acceptance I will begin to make the necessary arrangements with a view to holding a meeting - probably just after the main summer holiday season - possibly in early September.

<u>20's Plenty for Devon</u> – To consider correspondence in relation to joining the campaign for a reduced speed limit in cities, towns and villages in Devon and the appointment of a Councillor/s to represent the Council at any meetings that may arise and to which committee they will report

You may be aware that a growing number of Devon Parish Councils are campaigning to make 20mph the default speed limit where people and motor vehicles mix, with 30mph being an exception.

These Parish Councils have started their campaigns with the support of 20's Plenty for Us, a not-for-profit organisation which campaigns to make cities, towns and villages better places to be.

I am supporting the campaign through my role at Totnes Town Council as any effort put into getting 20mph limits locally might as well be put into the Devon-wide campaign to get DCC to change their default policy.

We are now trying to contact those Parish Councils that are not yet involved (as far as we know) to ensure that everyone has an opportunity to participate in this countywide initiative. Could you therefore please bring this email to the attention of your councillors.

We have two webinars coming up: 28 June, 1-2pm and 6 July, 7.30-8.30pm.

We can also arrange for 20's Plenty for Us to give you a Zoom presentation directly if neither of these dates are suitable.

There is increasing evidence that residents (and voters) want a 20mph default speed limit. They
are fed up with intimidatory and anti-social driving, air and noise pollution and in particular they
are concerned for their own safety and that of their families.

- There is now a considerable amount of research showing that the introduction of 20mph limits can be low cost and bring wide benefits, including fewer road casualties, less air and noise pollution, and increased walking and cycling.
- At present, Devon County Council's process for introducing 20mph limits is expensive, slow, adhoc and village-by-village. We are asking them to change their speed management policy to make 20mph affordable for local communities.
- Devon and Cornwall Police have indicated that they are supportive of 20mph limits. Even without their support, the evidence suggests that the imposition of 20mph limits means that drivers voluntarily reduce their speeds by up to 6 mph on faster roads.

<u>Active Travel Project</u> – To note correspondence providing an update on the West Devon Borough Council and South Hams District Council cycling and walking project and consider the appointment of a Councillor/s to represent the Council at any meetings that may arise and to which committee they will report

We are excited to now be in a position to provide you with more information about the cycling and walking project that is currently underway. We have appointed active travel consultants Phil Jones Associates together with Cycling UK to deliver this exciting piece of work, which is being funded from the UK Shared Prosperity Fund. This project is due to conclude at the end of this year.

The project has two halves that will come together to recommend a series of prioritised infrastructure measures and behaviour change initiatives in our main towns/larger villages (listed below for your information). The infrastructure side of the project is known as a Local Cycling and Walking Infrastructure Plan (LCWIP), this looks at existing circumstances and how things might beneficially change. It comprises a number of stages, as outlined below, throughout which we would like to work with you. These stages include:

- 1. Gathering data. The LCWIP is a data led project to map demand for future walking and cycling routes in our towns.
- 2. Identifying the main active travel routes between where people live and where they travel to
- 3. Auditing the main routes in each town and identifying barriers to active travel on these
- 4. Creating a prioritised list of interventions in each town to be supported if funding becomes available
- 5. Ensuring the outcomes of this project are integrated into Neighbourhood plans, Local Plans, Transport plans etc

There will be three main periods for engagement with Town/Parishes in this project as outlined below,
