<u>Okehampton United Charity – Nomination of Trustee</u> – To resolve to nominate a Trustee to Okehampton United Charity to fill the casual vacancy following the Ex Officio appointment of CIIr Fisher. The appointment will end on 18<sup>th</sup> October 2025.

Councillors were requested at the last meeting of Full Council to consider any nominations to fill this vacancy.

#### Okehampton Carnival

## To consider a request from the group for exemption from the Council's grant application process.

It has been suggested there is an historical agreement meaning the Okehampton Carnival Committee are given funding towards the annual carnival without the need to apply to the Council for a grant.

Investigation by way of enquiry with the parties involved confirms there is no written arrangement or correspondence in relation to such an agreement and that it was a verbal agreement. It is believed the fee charged to the third party for use of Simmons Park in the autumn is elevated over that of the spring/summer fee for this reason.

To ensure continued fair and transparent consideration of grant applications, and to avoid setting a precedence the following should be considered by the Council if there is a wish to support the previous informal agreement:

- The autumn fee be reduced to be in line with that charged for the spring,
- The Carnival Committee and third party come to a direct agreement in relation to a donation without unnecessary involvement of the Council,
- The Carnival Committee continue to apply for any additional funding they may consider necessary in line with the Council's grant policy.

# <u>Insurance</u> – To consider the quotation to increase the Fidelity/Commercial Crime Limit of Indemnity cover as recommended by the Council's insurer.

The quoted sum to increase the fidelity/Commercial Crime Limit of Indemnity to £1.2m until renewal of the policy in 2024 is £71.55, inclusive of 12% insurance premium tax.
