<p>357 <u>Apologies for Absence</u> - Apologies were presented on behalf of Cllrs Goffey and Weekes.</p>

<p>361 <u>Matters Arising</u> - 361.1 Pelican Crossing in Market Street - The Chairman reported on the response he had received from the County Highways Officer, who expressed the view that nothing further could be done. The Committee was of the opinion that further trials or work could be undertaken to alleviate the cause of the frequent traffic gridlocks and it was agreed that a question should be put to John Hart at the Superlinks Meeting on 7 December. - 364** **Joint Local Plan** - The Chairman reported that the three councils involved in the JLP would be arranging meetings to discuss the viability of new sites brought forward and expressed the view that the timescale for delivery of a new draft plan to the Inspector was unlikely to be before December 2017. The Chairman encouraged all Members to submit individual responses to the consultation in addition to the need for a town response.
- 365** **Chairman's Report** - The Chairman reported that there was a WDBC working paper on making site visits effective. One of the recommendations was to restrict town and parish council input. There was strong opposition to this suggestion and an updated draft was awaited. Cllr Leech also noted that there had been some discrepancies between the planning list he had received on his tablet and the list as circulated by Development Management, but accepted this might be due to formatting. He would report this back to WDBC. Cllr Leech
- 366** **20 mph Zoning** - Cllr Ireland had noted that road traffic in and adjacent to Hunters Gate was travelling at excessive speeds. This had been reinforced by anecdotal reports and discussion with other residents. Cllr Ireland asked what steps could be taken to introduce a 20 mph zone, what evidence was required and what procedure should be invoked. The Chairman suggested that there would be other areas to be considered in addition to Hunters Gate and it was agreed to ask Cllr Marsh to raise this at the next HATOC meeting (29 November).
