Declarations of Interest – Members are reminded that they should declare any relevant interest in the items to be considered. Cllr Yelland declared an interest as she is on the West Devon District Council Planning Committee.

- **Apologies for Absence** Apologies for absence were received on behalf of Cllr Weekes.
- **Deferments of Business** There were no members of the public present.
- **Members Questions** Cllr Cushing enquired about traffic enforcement issues previously raised. Cllr Leech advised that the enforcement officers would be attending the town on a more regular basis in the future.

Cllr Cushing enquired about the previously agreed use of a projector for planning meetings. Cllr Leech explained that this would commence once the new Clerk had had chance settle in and set up the system.

Cllr Cushing enquired about planning training. A response to an email to Patrick Whymer was awaited.
