## Minutes of Okehampton Town Council Policy and Resources Committee Meeting held on Monday 17<sup>th</sup> July 2017 at 7.00pm in the Council Chamber, Town Hall, Okehampton

- **Apologies for Absence** Apologies for absence were presented on behalf of Cllr Weekes.
- **Deferment of Business** No public presence.
- 106 <u>Members' Questions</u> Cllr Cushing queried min ref's 53 and 58 from the meeting held on 12<sup>th</sup> June. Cllr Yelland advised these would be done in due course once the new Clerk was properly in post.
- Minutes The minutes of the Policy and Resources Committee meeting held on 12<sup>th</sup> June 2017 were approved and signed by the Chairman on the proposition of Cllr Goffey, seconded by Cllr Leech.
- **Grant Applications** The Committee considered the following applications for Town Council grants:
- 108.1 Meldon Viaduct On the proposition of Cllr Goffey, seconded by Cllr Cushing and following a vote of 5 in favour and 1 abstention, it was resolved to grant £500 towards the maintenance and renewal fund, and that it was expected that Okehampton Hamlets match the grant. If any such grant was requested in 2018/19, it would be reviewed based on grants Okehampton Hamlets had provided.
- **108.2** Wren Music On the proposition of Cllr Leech, seconded Cllr Goffey, it was agreed to grant £500 towards the running of weekly summer music sessions in Okehampton over the summer period, specifically to support venue hire and the use of instruments.
- **108.3** West Devon Community and Voluntary Services On the proposition of Cllr Leech, seconded Cllr Goffey, it was agreed to grant £350 towards the update of their website.
- 108.4 Oke Pad's (Cllr Yelland declared a personal interest.) It was noted that this was a request for consideration of the possibility of a grant request in the future. It was pointed out that although there were already three defibrillators in the public domain, they were not available 24 hours a day.

On the proposition of Cllr Goffey, seconded Cllr Cushing, it was agreed that on receipt a grant request would be considered by the Town Council. It was further noted that a training session was being offered on 13<sup>th</sup> September for two Councillors. Item to be included on the next Full Council agenda.

- (vii) Okehampton and District Community Transport Group (Cllr Leech) The AGM is taking place on 20<sup>th</sup> July, this is open to the public.
