Dear Councillors,

Please accept this application on behalf of Okehampton United Charity, specifically relating to the provision of allotments in Okehampton. Okehampton United Charity currently provides three sites in the Town and Hamlets for the provision of allotments. There are 90 allotment holders and all three sites are fully let. The cost of providing the allotments is shown below:

Allotment costs 2020 (1st January 2020 to 31st December 2020)

Charity administration costs (8.8% of time in 2020 spent on allotments) = $\pm 2,527$ Total allotment maintenance costs up to 31^{st} December 2020 = $\pm 1,360.40$

Security £86.40 Maintenance (grass cutting, repairs) = £1,274

Total cost of allotments 2020 = £3,887.40

Rent received in 2020 £2,484.99 - £805 (Castle Road rent paid directly to Okehampton Allotment Holders Association for self-management of Castle Road) £1,679.99

NS - £420 CR - £805 FR - £1259.99

Deficit; net cost of providing allotments £2,207.41

Okehampton United Charity Charity No 202686 Okehampton Educational Foundation Charity no 306677 Trustees respectfully request a grant of 6/7ths £1,890 to contribute to the deficit for 2020.

In March 2020, the council awarded a grant of $\pm 5,650$ to contribute to the deficit for 2019 this was ± 285 less than the actual deficit due to a high number of applications received. It was suggested the charity include the ± 285 when applying for the contribution to the 2020 deficit.

Therefore the charity is applying for £2,175.

The benefit to Okehampton residents is the provision of allotments within the Town and Hamlets. A copy of the Charity's annual accounts have been supplied to the Clerk and I have asked Rev Mike
