4272/20/HHO The Clerk reported that a response to the request for further information from WDBC in relation to the use of the containers, as resolved at the meeting of the Committee on 1 st February 2021 Min Ref 640, had not been received and it had not been possible to contact the Planning Officers by phone.	
On the proposition of Cllr Jessop, seconded Cllr Ireland (1 abstention) it was RESOLVED to OBJECT to the retrospective application for retention of storage containers for use ancillary to enjoyment of dwelling house at 11 Maceys Terrace, North Road, Okehampton on the following grounds:	
<ul style="list-style-type: none"> • The design, siting and external appearance of the two large containers • The visual impact of the two large containers in an area designed to be green space 	

- The privacy/overbearing nature of the containers sited in a garden of a residential area
- The impact on the ecology and landscape in an area designed for green space
- Planning history
- The cumulative impact of two large containers sited in green/garden space in a residential area
- Retrospective application
- Light pollution – security type halogen lighting located on posts above the storage containers
- Concern that the containers are for commercial use and not in accordance with that stated in the application form

675 **Urgent Item** – Concern was raised regarding the difficulty experienced contacting and obtaining responses from WDBC Officers and it was **agreed** that reference to these issues be commented upon in the letter to be sent to WDBC as at Min Ref 673.
