Cllr Leech explained the fire and health and safety regulations was removed as it was not related to gambling and the licensing objectives and overlapped with building regulations. The Council RESOLVED on the proposition of Cllr Goffey, seconded Cllr Jessop, to respond to the consultation to ask the question if the revised legislation from WDBC would supersede the local bylaw concerning the banning of gambling licenced premises within the conservation area of Fore Street. Neville Road & Road to All Saints Church — On the proposition of Cllr Goffey, seconded Cllr Sanger RESOLVED to write a letter of complaint regarding the condition of Neville Road to WDBC on behalf of the resident.
On the proposition of Cllr Jessop, seconded Cllr Travers RESLOVED to report the complaint regarding the road to All Saints Church to Cllr Samuels DCC, who had previously requested the Council inform her of any problems with the local roads around Okehampton and to question the ownership of the road.

Speed Reduction – Cllr Tolley reported to the Council that he had received complaints from several residents regarding speeding along Crediton Road. Residents reported broken car wing mirrors and several near misses regarding both pedestrians and cars. Cllr Tolley asked the Council for any suggestions of how this could be addressed. Cllr Leech would pass details to Cllr Tolley of Community Speed watch UK which the residents may find useful. The suggestion of flashing, slow down or speed limit signs being installed was discussed. This would need permission from DCC Highways. Cllr Tolley thanked the Councillors for their advice and suggestions and would he approach Okehampton Matters.

## 345 Planning Applications

## 345.1 3068/21/FUL

On the proposition of Cllr Matravers, seconded Cllr Travers, one abstention, it was **RESOLVED** to object the application for erection of 2.5m high V-mesh fence on two sides of the school cricket pitch and installation of 1.2m x 1.8m gate, Okehampton Community College, due to the visual impact, historic/heritage aspect, and the economic impact due to the close proximity to a business. On the proposition of Cllr Sanger, seconded Cllr Wood, one abstention, it was **RESOLVED** to bring the matter to Full Council and propose a letter was written to the Trustees to show their objection to the application.

#### 345.2 3251/21/HHO

On the proposition of Cllr Goffey, seconded Cllr Wood, it was **RESOLVED** to support the application for the extension and alterations to dwelling, 2 Tors Road, Okehampton EX20 1LE providing the recommendations in the Ecological Impact Assessment was completed. Including installation of one bird box and one self-contained, self-cleaning bat box in the fabric of the extension or in a tree within the garden.

A motion to suspend Standing Order 3 (bb) to permit extension of the meeting was proposed by Cllr Jessop, seconded Cllr Tolley, and **agreed**.

#### 345.3 2368/21/HHO

On the proposition of Cllr Wood, seconded Cllr Goffey, it was **RESOLVED** to support householder application for erection of detached garage and replacement of existing integral garage door with window, 3 Abbey Rise, Okehampton providing the conclusion of the Aboricultural Impact Assessment, planting of 4 trees along the southern boundary post-completion was completed.

# 346 <u>Premises Licence Application</u>

On proposition of Cllr Jessop seconded Cllr Matravers, it was **RESOLVED** to support to the application for a new premises licence at the Plymouth Inn, 26 West Street, Okehampton for the sale of alcohol for consumption on and off the premises, Monday to Sunday from 10am to midnight.

**Planning Authority Decisions** – The following decisions made by the planning authority were noted.

## 2483/21/TPO - Tree works allowed

T1: Sycamore – removal of two limbs at approximately 8 metres from ground level on south southwest side.

T3: Sycamore – remove low epicormic growth at 6 metres from ground level and removal of limb at approximately 8 metres from ground level on west side:

T4: Sycamore – removal of 3 limbs at approximately 8 metres from ground level on north-west side.

T5: Sycamore – removal of 4 limbs at approximately 8 metres from ground level on north-west side, all due to excessive shading.

T1: Beech – Crown raise to 5m from ground level and lateral reduction by 2m on north side.

T2: Hornbeam – Crown raise to 5m from ground level and lateral reduction by 2m on north side.

T3: Sweet Chestnut – reduce limb at approx. 4m from ground level on north side by 3m and crown raise to 5m from ground level on north side.

Reasons: due to excessive shading and close proximity to roof.

T9: Beech – Crown lift to 3m from ground level to provide clearance from car park.

from ground level to provide clearance from neighbouring property.

T16: Conifer x 2 Crown lift to

3m from ground level to provide clearance from parked cars.

- 353 Member's Reports and Requests for Agenda Items -
- **353.1 Dartmoor Railway Association** Cllr Ireland thanked the members of the group that worked hard during the 150 years celebration event over the weekend.
- 353.2 OkeRail Forum Cllr Ireland reported there was a meeting on 21st October 2021
- **353.3** Ockment Centre Cllr Leech reported the centre was open a couple of days a week but would increase to full time now the Furlough Scheme had finished.
- **Okehampton & Area Health & Wellbeing Alliance** Cllr Wood reported the Terms of Reference for group was discussed. There had been an increase in demand for mental health provisions. Okehampton College had been working with Exeter Chiefs. A Craft and Wellbeing promotion event was to be held at the College on 23<sup>rd</sup> October. There has been no update regarding Okehampton Community Hospital usage. Foodbanks and a possible community fridge in West Devon had been discussed. Mental health service waiting lists had increased since the beginning of the pandemic. Men in Sheds were due to expand. The library had a taster day for children. The Good Grief Café was to reopen on 23<sup>rd</sup> October.
