Crown height reduction on northeast side of crown by up to 2 meters to create a 4.5 metre clearance from the house. Crown thin by approximately 20%. The tree is encroaching the property and excessively shading the garden ad adjacent garden the proposed removal of selected limbs along with the crown thin will help aid in the preventing excessive shade.
