Community Governance – Boundary Review

Okehampton Town Council is seeking the democratic view of its residents to demonstrate the support of the community for a proposal to change the boundary that lies between the town and its surrounding hamlets.

A change to the boundary would bring the recent urban developments into the town increasing the population. This would give OTC greater opportunity to:

- continue to afford community projects
- continue to provide services for the benefit of all
- give OTC a greater democratic voice within the county and central government
- bring increased opportunities and access to a wider range of funding
- to provide future growth opportunities

Full details of the proposal can be found at the end of this newsletter, on the council's website and is available from the Town Hall.

Without clear support from YOU, West Devon Borough Council do not have to undertake a review and may decide not to do so.

Town Council Grant Policy and Application Process

The council has reviewed its grant policy and the process for applying for a grant from the Town Council is changing in the next financial year. The change is to ensure that all applications are treated fairly and that applicants are not at risk of losing out towards the end of the financial year because the allocated budget has run out of funds.

From the 1st April 2023 applications will only be considered twice yearly by the Policy & Resources Committee; in the spring (May or June), and again in autumn (November or December) in line with the meeting schedule. Applications for consideration in the spring must be received by the 2nd Friday in March and those for consideration in November/December by the 2nd Friday in September.

Roadworks – Fore Street, Upcott Hill and Hatherleigh Road

Notification has been received from DCC Highways of planned roadworks in Okehampton.

• Fore Street - 15th to 24th August

Resurfacing from the crossing in the centre of the town outside of the Town Hall to the Fore Street/North Street junction. This work will be taking place overnight and the road will be closed daily from 6.30pm to 6.30am. During the evenings of 15th and 16th August the old surface will be removed. Noise levels may be higher so the work will finish by 11pm on these two days.

- Upcott Hill 22nd to 26th August for patching. Road closed from 7.30am to 5.30pm.
- Hatherleigh Rd 22nd to 25th August for resurfacing. Road closed from 7.30am to 5.30pm




Town Councillor Vacancy

Town Council Grants



Petition for a Community Governance Review of Okehampton Town

We, the undersigned, call on West Devon Borough Council to conduct a community governance review of Okehampton Town as the parish area served by Okehampton Town Council plus the surrounding Okehampton Hamlets Parish Council area that will be impacted. Any changes the review approves to be implemented as soon as possible.

The petition requests that the governance review focuses on the following:

Okehampton Town Parish Boundary – It is requested that a parish boundary review considers the change to the parish boundary to incorporate the urban developments and future potential expansion sites into the town.

Parish Wards – It is requested that the wards that currently make up the Okehampton Town Council parish are removed and all elected members be elected to serve the whole Okehampton Town parish area.

Okehampton Town Councillor Numbers – It is requested that the number of Councillors remain at the existing number of 14 to serve in the single Okehampton Town Council parish area.

It is requested that if the governance review is concluded and a Community Governance Reorganisation Order is issued under the provision made in the Local Government and Public Involvement in Health Act 2007 the changes are implemented to take effect within 18 months of submission of the petition to West Devon Borough Council.

Why is this important?

Okehampton is served by two grass roots local councils; Okehampton Town Council (OTC) and Okehampton Hamlets Parish Council (OHPC). Historically OHPC has consisted of the rural areas with OTC containing the urban housing and commercial businesses.

The greater Okehampton area has and continues to grow significantly with substantial housing and commercial development. This includes a new Primary School, a planned new Special School, a Business Centre and the reinstatement of a regular passenger rail service between Exeter and Okehampton Station, and proposed Parkway.

Recent urban development, both commercial and dwellings, is almost all outside of the Town boundary and encroaching heavily on the rural hamlets. Comments from social media and correspondence suggests many residents of the new developments believe they are part of the Town. They directly benefit from all of the services and facilities that are offered by OTC including, but not limited to:


- Public toilets at Fairplace and in Market Street
- Simmons Park recreation facilities
- Skate Park/BMX track
- Cemetery
- CCTV in the town and Simmons Park

Residents of greater Okehampton should be able to feel part of the urban area and have a democratic voice in the community they believe they are part of, bringing a sense of community inclusion and identity.

A change to the boundary would bring the recent urban developments into the town increasing the population. This would give OTC greater opportunity to:

- continue to afford community projects
- continue to provide services for the benefit of all
- give OTC a greater democratic voice within the county and central government
- bring increased opportunities and access to a wider range of funding
- to provide future growth opportunities

The proposed boundary will encompass current development as well as allowing a buffer for future growth that is likely to occur. All of this could lead to the obtaining of more investment in the town for infrastructure including transport and highways improvements.
