**Devon County Council (Various Roads, Devon) (Weight Restriction) Amendment Order**

Devon County Council makes the following order under sections 1, 2 of the Road Traffic Regulation Act 1984 and of all other enabling powers

**Part 1 Introduction**

1.1 This order comes into force \_\_\_\_\_ and may be cited as “Devon County Council (Various Roads, Devon) (Weight Restriction) Amendment Order \_\_\_\_\_”

**Part 2 The County of Devon (Various Roads, Okehampton Area) (Weight Restriction) (Consolidation) Order 2000**

2.1 The County of Devon (Various Roads, Okehampton Area) (Weight Restriction) (Consolidation) Order 2000 is amended as follows

2.2 In Article 3, after “Save as provided in Articles 4” insert “, 4A ”

2.3 After Article 4, insert “4A. Nothing in Article 3 of this order shall apply so as to prevent any persons from causing any goods vehicles to proceed in the lengths of road specified in Schedules 1 and 2 to this order if the vehicle is following the official diversion route when the A30 is closed”

**Part 3 Devon County Council (Cullompton, Halberton, Sampford Peverell & Willand) (Weight & Length Restriction) Order 2018**

3.1 The Devon County Council (Cullompton, Halberton, Sampford Peverell & Willand) (Weight & Length Restriction) Order 2018 is amended as follows

3.2 In Article 5, after “Save as provided in articles 8” insert, “, 8A”

3.3 After article 8, insert, “8A. Nothing in article 5 prevents any persons from causing a vehicle to proceed in the specified lengths of road in Schedule 3 of this order if the vehicle is following the official diversion route when the M5 is closed”
