**0664/23/VAR** – On the proposition of Cllr Tolley, seconded Cllr Ireland (1 abstention), it was **RESOLVED** to OBJECT to the application for variation of conditions 2 (approved drawings) and 4 (fence details) and removal of condition 5 (surface water drainage) of planning consent 2342/19/FUL to allow for improved privacy for neighbours and address drainage restrictions within the site at St James Church of England Primary School, Fort Road, Okehampton EX20 1GJ on the following grounds:

- Visual impact on neighbouring properties
- Planning history
- Design and appearance of the proposed pitch and fence height
- Privacy and overbearing nature of the proposal on neighbouring properties
- Loss of daylight/sunlight to neighbouring properties, especially once the trees are planted and have matured
- Ecology and landscape

**0621/23/TCA** - On the proposition of Cllr Goffey, seconded Cllr Ireland, it was **RESOLVED** to support the application, subject to the recommendations of the Tree Officer, for T1: Horse Chestnut – thin deadwood, remove crossing branches, crown height reduction by 5m to reduce weigh on weak V unions at 12m from g/l, T2: Beech – remove crossing branches, crown height reduction by approximately 25ft, T3 & T7: Lime – reduce branches overhanging by approx. 25ft, T4 & T5: Chestnut – remove deadwood/crossing branches, T10: Beech – thin deadwood/crossing branches, T12 & T14: Chestnut – fell, T13: Beech – fell, T15: Beech – fell, T16: Lime – remove limb on North Side overhanging neighbours car park, T17: Beech – crown height reduction by 25ft, T18: Lime – reduce branches overhanging car park by 10m. Land at SX 592 948, Okehampton Community College, Mill Road, Okehampton EX20 1PW
