- 617 **Railway Bus Links** – The Committee were concerned there would be a reduced bus service serving the current railway station when the new Transport Hub was in service. It was agreed both stations needed to have a regular bus service. This would be discussed at the next OkeRail meeting.

- 0451/24/TPO** It was noted the following application had been withdrawn.
T001: Atlas cedar – Fell tree to ground level, tree will never fully form on southern side due to frequent pruning and to minimise future issues with drainage services, re-planting a more suitable tree away from underground above ground services. T002 Rowan – Fell to ground level due to being in decline and entering services causing damage/disruption. T003: Rowan – Fell tree to ground level due to being dead. T004: - Norway Maple – Fell tree to ground level, justification the base of the tree has occluded a wooden post successfully, this tree is directly above main lateral sewer drain which is also considered to have root ingress and have severe defects, this tree is also directly above drainage services and is more than likely causing root ingress within drainage system.

4219/23/TCA T1 – Ash, fell due to dieback disease (referred to as T004 in the Tree Survey/Risk Assessment), T2 – Sycamore, crown lift of lowest hanging branch to a height of 8 meters from ground level, this being the height at which the branch joins the tree trunk, to allow use of the area and increase light levels. Cemetery Extension, South Church Lane, Okehampton EX20 1LE

3755/23/TPO T1: Species unknown – crown height reduction by 5m to allow light into property, concerns tree may fall.

Premises Licence - Application from the Home Office Enforcement to revoke the Premises Licence at Rajpoot, 25 Fore Street, Okehampton, EX20 1DL.

624.1 **Dartmoor Railway Association** – Cllr Ireland reported there was a OkeRail Executive Group meeting on 7th March, and he would add to the agenda the issue regarding bus timetables to both stations. Network Rail would be attending the Annual Town Meeting on 8th April at the Ockment Centre, and the public would be able ask questions direct to them. They were discussing the possibility of a Summer Sunday Service.

624.4 **Okehampton & Area Health & Wellbeing Alliance** – No report.

624.5 **Beacon Path, Sticklepath to Okehampton** – Cllr Bird reported they meet bi-monthly. She was disappointed GWR were not encouraging bikes on the trains and not supporting Active Travel. Cllr Bird had tried to book a bike space, but they were never available although there were empty spaces on the trains for the bikes. Cllr Ireland would raise the issue with OkeRail and GWR at the next meeting.
