As you are aware this Council have set up a Speedwatch Group with myself as the Coordinator. We have enough trained volunteers to progress to obtaining all the equipment from the Police, receive training from them and then undertake activities.

I am retiring as Parish Clerk and the Speedwatch Group therefore require a new Coordinator. OHPC Councillors decided at their recent meeting that this was not something the new Clerk could continue going forward.

The Group is currently named 'Okehampton Hamlets Speedwatch Group', this could be revised to something like 'North Dartmoor Speedwatch' potentially incorporating Sticklepath, Inwardleigh and Sampford Courtenay.

Please could you/your Councils give this consideration. Sadly unless a new Co-ordinator is found the Group will not be able to continue and move forward.

•	Been disqualified from being a company director	
•	Been subject to an investigation by HM Revenue and Customs, which has resulted in a prosecution.
