10. Projects and Consultations

10.3 Okehampton Neighbourhood Plan - To consider recommendations from Cllrs Colman, Cummings and Richards in relation to the area to be included in the Neighbourhood Plan and accompanying statement to be submitted to WDBC

Application under Part 2 (5) (1) of The Neighbourhood Planning (General) Regulations 2012 for the designation of a Neighbourhood Area

Okehampton Town Council give notice that we wish to make an application under Part 2 (5) (1) of The Neighbourhood Planning (General) Regulations 2012/2015 for the designation of a Neighbourhood Area for the Neighbourhood Development Plan.

A map identifying the area to which the application relates, being the area covered by the introduction of the new Okehampton Town Boundary in 2027, as agreed following the Community Governance Boundary Review between Okehampton Town Council and Okehampton Hamlets Parish Council.

Okehampton Hamlets Parish Council gave permission at a meeting on 1st April 2025 for the land that will transfer to the Town in 2027 to be included within the Okehampton Neighbourhood Plan.

This area is considered appropriate to be designated as a neighbourhood area for the following reasons: -

Okehampton Town Council have agreed that the area for which its responsibilities will cover should be covered by a Neighbourhood Plan, to ensure the interests of the Community are upheld in future planning. To provide a vision for the future of Okehampton, while maintaining the standards of properties and developments to suit the demands of a growing Town in Devon.

To investigate and suggest ways to support the local infrastructure, from roads to public services like health care, transport, education and development of jobs in the area. This list is not limited to these suggestions.

It is true that there is limited scope for any further developments of any kind in Okehampton Town Councils areas, the greater scope is within the former Hamlets areas. Currently the expansion of Okehampton continues in what is currently the Hamlets area to the East of the Town.

The new Town Boundary offers the scope for various projects and in many ways blue sky thinking, the neighbourhood plan will assist in this process, looking at all the aspects of planning and regeneration to help make Okehampton become the thriving Town it used to be with community at its heart.

Okehampton Town Council resolved to develop a plan for the neighbourhood area at a council meeting on 2^{nd} June 2025.

The community agreed that a neighbourhood plan should be developed several years ago, unfortunately this plan did not pass the required standard, and therefore a new Neighbourhood plan is required.

The current plan is to submit this application to West Devon Borough Council. Should this plan be approved by West Devon Borough Council, a steering group will be created by the Town Council to take the Neighbourhood plan forward.

Okehampton Town Council is the relevant body for the purposes of section 61G of the 1990 Town and Country Planning Act being the parish council for the entire area applied.

10.5 Local Cycling and Walking Infrastructure Plan (LCWIP) – To consider a response to the proposals

Dear Okehampton Town Council and Okehampton Hamlets,

I am writing to let you know the Local Cycling and Walking Infrastructure Plan (LCWIP) was adopted by West Devon Borough Council HUB committee on 10 June. You can access the full LCWIP report using the following link: https://www.westdevon.gov.uk/communities/local-cycling-and-walking-infrastructure-plan-lcwip

The LCWIP report contains a very large number of possible 'interventions' that would improve conditions for walking, wheeling and cycling across West Devon (and South Hams), however these are very costly and the majority would involve highway works and so would need DCC approval to progress them. West Devon Borough Council currently holds a small amount of funding allocated for active travel projects, and so we are now looking to identify a couple of locally supported projects (across all of West Devon) that DCC could support to deliver. I do need to empathise that, in relation to the cost of highway infrastructure costs, there is only a small amount of active travel funding available to progress one or two smaller scale intervention projects. The delivery of other active travel infrastructure projects would only follow when further funding is secured, e.g. by S106 when the LCWIP is embedded within a revised Local Plan.

The attached spreadsheet shows the prioritised routes identified in the LCWIP in West Devon and contains two tabs: 'Quick Wins' and Longer term', and illustrates the ranked priority routes and the interventions suggested along these, in column J and K on the different tabs. Please note that there are often multiple interventions listed in one cell, which are defined by a unique reference number such as 'WD-3-L2'. You might wish to identify the locations of the interventions on the CommonPlace platform that was used for the <u>public consultation here</u>. I have filtered the spreadsheet so it should only show routes that relate to: **OKEHAMPTON**

10.6 North Devon Health Initiative – To note the <u>survey</u> which can be completed by councillors as individuals

Health Service Survey to discover current and potential usage of Okehampton hospital.



Okehampton Community Hospital still hosts over 40 clinics and specialisms, even though its wards and GP practice were closed in 2016. **But not enough people know that this facility is there for us.** At a time of great pressure on the NHS, we believe that Okehampton and its surrounding area should use this facility more.

This short survey will help us find out whether residents are

- Aware of the hospital.
- Use the hospital when applicable.
- Would use the hospital as an alternative to RDE/ Derriford, if possible.

The Community Hospital was built in 2004, (with £250,000 locally raised funds) and serves around 42,000 people who live within 15 miles of the town. Initially the Community Hospital had a state-of-the-art Maternity Unit with a Birthing Pool, a Physiotherapy Department, X Ray Unit, a Dialysis Unit, Podiatry, several other clinics including 24/7 MIU and over 30 inpatient beds in 2 wards. Over the years we have lost the wards and several of the services.

We want to improve health service provision in Okehampton and the surrounding area, which is getting less than its fair share of NHS Devon's resources. Therefore, we need to give hard evidence to the NHS of what is needed. So please answer the questions overleaf with the: QR Code

11. <u>Letters of Recognition</u> – To consider a proposal from the Mayor in accordance with the circulated report

Report Title: Mayor's Proposal – Letters of Recognition for Emergency Services Personnel

Purpose of Report:

To seek Council's approval for the Mayor to introduce a new initiative recognising members of the emergency services including Dartmoor Search and Rescue who have either:

- completed 10 years or more of service,
- demonstrated exceptional bravery or heroism, or
- given service posthumously.

Background:

- The Mayor has expressed a wish to acknowledge the commitment and sacrifice of emergency services personnel, including Dartmoor Search & Rescue, in serving the people of Okehampton.
- Recognition would take the form of a formal Letter of Recognition from the Mayor, issued on behalf of the Town Council on headed paper.
- This is intended to be separate from the Mayoral Awards, which remain focused on exceptional community or voluntary service.

Proposal:

- That the Mayor in conjunction with the Town Clerk be authorised to write letters of recognition to qualifying emergency service personnel.
- Emergency service organisations (Police, Fire, Ambulance, Dartmoor Search & Rescue) will be invited to submit nominations using a standard form (Appendix A).
- Nominations will require confirmation from the organisation that the individual consents to their details being shared with the Council, or that in the case of posthumous recognition, the family has been consulted.
- Minimal personal data will be collected in line with GDPR.

Criteria:

- 1. Minimum of 10 years' service in the emergency services, including Dartmoor Search & Rescue; or
- 2. Demonstrated exceptional bravery or heroism in the line of duty; or
- 3. Posthumous recognition where service or sacrifice warrants acknowledgement.
- 4. Nominations may only be submitted by the relevant emergency service organisation.
- 5. Recognition will take the form of a personal letter, not a public award ceremony, and is separate from the Mayoral Awards.
