- **460.** <u>Apologies for Absence</u> Apologies were presented on behalf of Councillors Marsh and Rush.
- 461. <u>Deferment of Business</u> No public presence.
- 462. <u>Members' Questions</u> Cllr Ireland enquired as to progress on unauthorised parking in East Street. The Chairman reported that he had passed this matter to the Devon County Council Member to take forward. Cllr Goffey observed that the motorcycle chained to the gate in East Street was now subject to a West Devon Borough Council enforcement notice.

## 465. <u>Planning Applications</u>:

#### 4078/16/TPO

Works to a tree under preservation order.

T1: Sycamore – selectively thin crown by approx. 15-20% and target prune limbs and branch growth to dwelling back by approx. 2-3m at suitable growth point. T2: Sycamore – target pruning approx. 1m from branch tips to previous pruning points within tree crown. G1: approx. 4xSycamores – target prune lateral branch growth back to parent stem by approx. 2-3m – only branches growing towards property boundary. T3: Elderberry bush – target prune branches approx. 2m from branch tips to suitable growth points at 33 North Street, Okehampton EX20 1AR. Mrs S Gibson Resolved to support the application on the proposition of Cllr Goffey, seconded Cllr Weekes.

**467.** <u>Joint Local Plan</u> - Cllr Leech reported that the final draft of the Joint Local Plan was due to be published in February or March for consultation prior to forwarding to the Inspector. This consultation would be the last opportunity to input to the plan in its pre-submission stage.

# 468. <u>Neighbouring applications for the attention of the Council</u> -

**4059/16/VAR** - The Committee noted the application was for a largely Hamlets-located development which would have significant impact on the Town. On the proposition of Cllr Cummings, seconded Cllr Stephens it was agreed to make representation on the following points:

- a) the roundabout should be delivered upon the delivery of the 150<sup>th</sup> dwelling, not on its occupation as proposed
- b) to urge retention of all provisions of the existing section 106 agreement for the benefit of the community
- c) to ensure that parcel 2 was fully developed as a parcel and not linked to the development of parcels 3 and 4.

### 469. Members' Report and Reminders for Agenda Items -

- (i) Dartmoor Railway Supporters' Association (Cllr Ireland) This weekend the Association was supporting Dartmoor Railway in organising a Diesel Supporters' Weekend. The Association was also supporting an Awareness Event in Bude on 18 February to promote the need for a passenger rail service from Okehampton.
- (ii) Ockment Centre (Cllr Leech) Garden work continues to create open spaces.
