**577. Joint Local Plan** - The Chairman reported on the consultation events organised by West Devon Borough Council during March and on the briefings that WDBC Members had received on the Joint Local Plan (JLP). Councillors of both Town and Hamlets had also met informally last Thursday to discuss areas of common interest and the parameters for response to the consultation set out by WDBC.

It was agreed that a Planning Committee scheduled for 24 April (before closure of consultation on 26<sup>th</sup>) would include consideration of a formal response from Okehampton Town Council to the consultation. In order for this to happen, Members were asked to submit their contribution by not later than 18 April to Cllr Leech, copied to the Town Clerk. The key areas of focus were:

- prioritisation of the Exeter Road-Crediton Road link
- prioritisation of a town centre relief road
- emphasis of employment and infrastructure before residential development
- alternatives to eastward extension of the settlement boundary
- emphasis on a functioning town centre.

**578. Chairman’s Reports** -

**578.1 Strategic Housing and Land Availability Assessment** - Cllr Leech reported on the submissions of land offers received in the Neighbourhood Planning process; that there was a mix of potential brown-and greenfield sites and that the next step would be to classify the identified areas for purpose through public consultation prior to policies being formulated.

**578.2 Settlement Boundary** - Cllr Leech produced a map showing the settlement boundary for Okehampton and Hamlets Parishes and reported that the

boundary had been altered to the east to reflect the outline planning permission that had been granted for parcel 4, which was previously outside the boundary. It was hoped that the offers of land elsewhere within the town and to the west of Okehampton would result in the development of this parcel not proceeding.

**579. Members' Report and Reminders for Agenda Items -**

- (i) Dartmoor Railway Supporters' Association (Cllr Ireland) - The Sunday Rover Service due to operate between 21 May and 10 September, but the 08 shunter is currently under repair and there is a concern that there may not be a locomotive to power the heritage trains during this period. Great Western had undertaken to produce leaflets for the outgoing and inbound services.
- (ii) Ockment Centre (Cllr Leech) - Volunteers had now succeeded in removing all plants from the gardens thereby creating more open space.

It was resolved that under section 1(2) of the Public Bodies (Admission to Meetings) Act 1960 that the public and press be excluded from the meeting for the following item as it involves the likely disclosure of sensitive and confidential information.
